**IMAGE REPRODUCTION TERMS AND CONDITIONS**

**1. ACCEPTANCE**

- a) The client agrees to comply with the following terms and conditions. Permission to reproduce from the digital photographic material supplied is dependent upon the full acceptance of the conditions listed below and will be abrogated automatically if any conditions are infringed. Payment of the tax invoice supplied implies acceptance of the terms and conditions.

**2. LICENCE**

- a) The rights granted by are strictly limited to the use, period of time and territory specified on the licence. Invoices for reproduction rights issued by YOUR ORGANISATION do not constitute a licence, implied or actual, to grant the rights specified until payment of the invoice in full has been received. On full payment of the invoice, reproduction rights are granted to the client, as specified on the licence and are not transferable.
- b) The image may not be cropped, bled, overprinted, obscured by print or other text or altered in any way without the prior, written approval of YOUR ORGANISATION and/or the copyright owner. Applications for details, book covers and commercial products will be considered upon supply of proposed design and must be approved by this department prior to production.
- c) Image and copyright captions must be used without any alteration or abbreviation and appear in association with the image except with permission from YOUR ORGANISATION. It is the publisher's responsibility to acknowledge the artist and their work correctly in accordance with the Australian Copyright Act's Moral Rights.
- d) If a detail of the image is used, the word 'detail' must appear in parenthesis after the title and date of the artwork.
- e) YOUR ORGANISATION reserves the right to refuse to supply material or to withdraw approval, where the context of the reproduction is deemed to be unsuitable, inappropriate or contrary to the artist or YOUR ORGANISATION interest.

**3. COPYRIGHT**

- a) YOUR ORGANISATION reserves copyright on all digital images or films made by YOUR ORGANISATION. The supply of digital images does not confer the rights to store or reproduce them or make them available to the public in any medium or form except for the reproduction or communication rights stipulated on the licence. Nor does the supply of photographic material imply the availability of these rights.
- b) Where YOUR ORGANISATION does not control all the rights, we will notify the applicant of any further rights that need to be obtained. It is the client's responsibility to obtain a copyright licence for any reproduction.

#### **4. PAYMENT**

- a) Permission to reproduce is only granted after the invoice has been paid. Pre-payment of all orders must be made before the release of the photographic material. Payment will only be accepted in Australian dollars or by credit card. Bank transfer fees must be paid by the applicant.
- b) In order to ensure quality control, **YOUR ORGANISATION** only allows reproductions from its own photographic material. Digital images are supplied via Dropbox. Any postage and packing is charged to the client and special delivery arrangements, such as couriers are at the expense of the client
- c) Unless otherwise agreed, one complimentary copy of the product, publication or publicity material containing a reproduction of the image must be supplied to **YOUR ORGANISATION**. This should be sent to the Communications department on publication.

#### **5. INDEMNIFICATION**

- a) The client agrees to indemnify **YOUR ORGANISATION** in respect of any claims or damages or any loss or costs arising in any manner from the reproduction of images unless granted under the terms of these terms and conditions.
